And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 288<sup>th</sup> meeting held on 15<sup>th</sup>–16<sup>th</sup> February, 2018 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to Faculty of Education, ICFAI University, Plot No. – 46/65, 66 (1,2,3,4,5), 68, 69, 70, Village - Chorha RI Circle, Ahiwara, Kumhari, Dhamda, Durg, Chhattisgarh - 490042, for conducting B.Ed. programme of 2 (Two) years duration with an annual intake of 100 students (two units of 50 students) from the academic session 2018-2019.
